Bargaining Update

OPEIU LOCAL 8 AND Samaritan Healthcare have held three (3) negotiations, and one (1) Mediation session, where numerous proposals including economics were exchanged, and several tentative agreements have been reached. However, we are far apart on economics and several other important items relating to your working conditions.

- Cost of Living increases / Wages
- · Filling in missing Steps on the Wage Schedule
- Certification Pay
- Spanish Interpretation Pay
- Union Security
- Scheduling
- Rest Between Shifts Pay
- Stand By Pay
- Extended Illness Leave

Our next mediation session is scheduled for **Tuesday**, **October 10**, **2017**.



The OPEIU has partnered with Higher Education Partners (HEP) and Eastern Gateway Community College (EGCC) to provide OPEIU members and their families with the opportunity to earn an associate degree on line for **free** — no out-of-pocket costs for tuition, fees or e-books. Students study online and can earn an Associate of Arts, an Associate of Business Management, an Associate in Early Childhood Education or an Associate in Criminal Justice. The



OPEIU Free College Benefit is open to members in good standing, who are full-dues-paying members and their families. Family is defined as spouse, children, stepchildren, children-in-law, dependents and grandchildren. Potential students' membership will be verified by OPEIU.

OPEIU Student Debt Reduction Program

OPEIU members are eligible for the OPEIU Student Debt Reduction Program to help OPEIU members and associate members repay their student debt. The fund provides five awards of \$2,500 each year to a member who has completed an associate or undergraduate degree and who can demonstrate they have at least \$10,000 in student debt and their account is current. The deadline for 2017 has passed; the application deadline for 2018 will be June 30, 2018. Look for more information on our website in the spring of 2018.
