The Committee has been working on the template for the Red Book, so that each site has the necessary information on site in case of an emergency.

The Washington State Administrative Code requires that the Safety Committee meets on a regular basis, and cover the following topics:

- ◆ Review safety and help inspection reports to help correct safety hazards.
- ◆ Evaluate the accident investigations conducted since the last meeting to determine if the cause(s) of the unsafe situation was identified and corrected.
- ◆ Evaluate your workplace accident and illness prevention program and discuss recommendation for improvement, if needed.
